- **Privacy** → We only use your data to deliver the Service or with your consent.
- **Legal stuff** → Governed by Portuguese law, with disputes handled in Porto, Portugal.

Terms & Conditions

Effective Date: November 3, 2025

These Terms & Conditions (“Terms”) are intended to establish the legal terms applicable to purchases made during the Golden Alpha Week — a promotional sales period running from 3 November 2025 to 11 November 2025 - and govern your purchase and use of the Digital Services (“Services”), provided by Alphasoul, Lda., a company incorporated and registered in Portugal (“Alphasoul,” “we,” “our,” or “us”). By purchasing or using the Services, you agree to these Terms. If you do not agree, please do not use the Service.

1. Understanding These Terms

- “We,” “our,” and “us” refer to the Alphasoul
- “You” or “Customer” refers to the individual purchasing and using the Service.
- Please read these Terms carefully and save a copy for your records. Your use of the Service means you accept these Terms.

2. Purchased Services under Golden Alpha Week

The services offered during Golden Alpha Week are considered **digital services** under Portuguese law (Decree-Law No. 84/2021 of 18 October, as currently in force). These services are delivered remotely, in a digital format, through the Cademi online platform, where customers will access the recorded digital content.

During Black Friday Week, customers may purchase our audio and video business-acceleration programs — including programs Shapeshifter, Cashgasm, Experienced, Orgasmic Business Season and Highly Influential — at the lowest price offered within the past 30 days.

All programs are designed for entrepreneurs and business owners who want to:

- Strengthen their entrepreneurial mindset and leadership skills
- Learn sales strategies that create consistent and recurring revenue
- Improve the customer experience from onboarding to service completion

- Develop tailored offers that meet client needs
- Build a strong and attractive digital and social-media presence

These programs are intended to help customers grow their businesses and achieve their business goals by applying the knowledge and tools available within the Cademi platform.

3. Bundled Purchase during Golden Alpha Week

During Golden Alpha Week, the digital services above are **not available for individual sale**. They must be purchased as a bundled package (“Bundle”). The available Bundles are:

- **Bundle I: The Initiation** — includes programs *Shapeshifter* and *Cashgasm*
- **Bundle II: The Expansion** — includes programs *Experienced* and *Orgasmic Business Season*
- **Bundle III: The Empire** — includes programs *Orgasmic Business Season*, *Cashgasm*, *Experienced* and *Highly Influential*

4. Our Responsibilities

We will:

- Provide access to the audio playlist or/and video-classes on *Cademi platform*.
- Help you access and use *Cademi platform*.
- Ensure *Cademi platform* is reasonably functional, compatible, and secure.
- Suspend or terminate your access if you cancel your installment payment card (e.g., via Klarna) without providing an alternative payment method.

5. Your Responsibilities

You agree to:

- Pay all fees associated with the Service.

- Maintain a valid payment method and not cancel or block payments without arranging another method with us.
- Not copy, share, distribute, or sell any content provided.
- Respect our intellectual property rights.

If you breach these obligations, we may suspend your access and pursue legal remedies under Portuguese law, including damages as provided under **Article 798° and following of the Portuguese Civil Code**.

6. Pricing and Payment Terms

The annual subscription price for each digital service package (“Bundle”) referenced in 2 is:

- **€33 (thirty-three euros)** for Bundle I: *The Initiation*
- **€111 (one hundred and eleven euros)** for Bundle II: *The Expansion*
- **€222 (two hundred and twenty-two euros)** for Bundle III: *The Empire*

Each price will be clearly displayed both on the service sales page and on the payment platform (Stripe) used to complete the purchase.

Please note that the prices shown on the sales page and on Stripe **include all applicable taxes and fees related to the provision of these services**.

Payment may be made in full or in installments through Klarna. Klarna is an independent third-party service, and we are not responsible for disputes between you and Klarna. Your agreement with Klarna does not affect your obligations under these Terms.

If you cancel your payment card without providing an alternative, you will be in breach of contract under **Portuguese Civil Code provisions**.

All prices are stated in **euros (€ EUR)**. If you are purchasing from outside the Eurozone, your bank or payment provider may apply currency conversion rates and/or fees. We do not control or charge these fees.

7. Previous Prices Before Golden Alpha Week

For purposes of transparency and in compliance with Portuguese law, Alphasoul confirms that the promotional prices listed in Section 5 represent the lowest prices applied during the 30 days prior to the Golden Alpha Week promotional period.

The lowest prices previously applied to each service were:

- **Shapeshifter** — €33 (thirty-three euros)
- **Cashgasm** — €22 (twenty-two euros)
- **Experienced** — €222 (two hundred and twenty-two euros)
- **Orgasmic Business Season** — €22 (twenty-two euros)
- **Highly Influential** — €200 (two hundred euros)

8. No Artificial Price Inflation

Alphasoul confirms that prices were not increased immediately prior to the promotional period for the purpose of advertising higher discounts. All promotional pricing reflects genuine, previously applied pricing.

9. Refund Policy

You have **14 days** from the purchase date to cancel for a full refund (“right of free termination”), in line with Portuguese law.

To exercise this right, send an email to vanessasilva.info@gmail.com with the following declaration:

“I, [name], resident at [address], phone [number], email [email], hereby cancel my contract with Alphasoul for the Bundle of Digital Services purchased on [date].”

Refunds will be made to the original payment method.

After 14 days, no refunds or exchanges are available, even if you did not use the Service.

You lose the right of cancellation if you access audio files, video classes or if the Service begins within the 14-day withdrawal period.

10. Intellectual Property

All materials provided (including audio files) are the exclusive property of the Alphasoul.

The Alphasoul brand and registered methods are protected under **Portuguese law (Decree-Law number 110/2018, of December 10, as amended)** and by the **Property Law National Institute (INPI)**. Unauthorized use may result in penalties.

11. Privacy & Data Use

We collect and use your personal data only to deliver the Service and related communications (e.g., sending access instructions).

We may share pseudoanonymized results for promotional purposes but will not disclose identifying information without your consent.

For newsletters or promotional emails not directly related to the Service, we will request your prior consent.

12. Disclaimers & Limitation of Liability

The Service is provided “as is.” We do not guarantee uninterrupted access to third-party platforms like *Cademi platform*.

If *Cademi platform* becomes unavailable, we will provide similar access when reasonably possible.

If replacement is not feasible or causes disproportionate costs, you may be entitled to a proportional price reduction or full refund, depending on when the disruption occurs, in accordance with Portuguese law.

13. Governing Law & Jurisdiction

If you are not satisfied, please contact us first to resolve the issue.

If no agreement is reached, these Terms are governed by **Portuguese law**, and disputes fall under

the jurisdiction of the **Comarca of Porto (Portugal)** or applicable out-of-court dispute resolution mechanisms.

14. Updates to Terms

We may update these Terms. If changes are significant, we will notify you via email or on our website. Continued use of the Service after changes means you accept the updated Terms.
